## MINUTES OF THE TOLEDO COUNCIL REGULAR MEETING HELD AT THE REINIG CENTER, 1007 S. PROSPECT DRIVE, TOLEDO IA STARTING AT 5:00 P.M.

Under new business, Cook motioned to approve publishing and setting public hearing for the FY25 property tax levy for the April 1, 2024 special meeting, seconded by Pansegrau. All present voiced ayes, no nays, motion carried.

Pansegrau motioned to approve the City Bridge funding agreement to replace the bridge on  $300^{th}$  St. over Deer Creek, seconded by Cook. Roll call vote: all present voiced ayes, no nays. Motion carried.

Jordan will get prices on what it would cost for the city to purchase their own mosquito sprayer and present those to the council at the next meeting.

Boll motioned to approve increasing allocations for the Aquatic Board by \$3,000 each year to keep pace with the market, seconded by Goodhart. All present voiced ayes, no nays, motion carried.

Under old business, Pansegrau motioned to approve a year subscription with the Wolfcom System, seconded by Boll. All present voiced ayes, no nays, motioned carried.

The council felt a donation to the Tama County Humane Society met the public purpose aspect for the community to help defer the cost of stray animals that are taken to the shelter by the Toledo Police Department. Cook motioned to approve a \$500.00 donation, seconded by Vesely, all present voiced ayes, no nays, motion carried.

Mayor Sokol moved to department, council reports, and public comments. EMS Director, Greg Johnson mentioned he is looking for ambulance drivers and volunteer firefighters. Hearing no further comments, Vesely motioned to adjourn regular meeting and move into closed session at 5:43 p.m. pursuant to lowa Code 21.5 (1)(c), seconded by Pansegrau.

Cook motioned to return to open session from closed at 5:53 p.m., seconded by Pansegrau. Roll call vote: all present voiced ayes, no nays, motion carried. There was no action taken from the closed session. Hearing no further comments, Pansegrau motioned to adjourn, seconded by Vesely. All present voiced ayes, no nays, meeting adjourned at 5:54 p.m.
