What We Are About.....

The central purpose of the Toledo Fire Department is to protect life and property against loss from fire, storm, flood and other disasters. This purpose is accomplished by three phases of operation: Preparation, anticipation and action

In order to become proficient in all phases of firefighting, members of the Toledo Volunteer Fire Department are expected to participate in training sessions conducted by the department. All members should make every effort to complete the fire fighter one course as soon as possible. It is important to remember that training in the fire service is a continuing process and no training activity should be taken lightly.

Each member should strive to become proficient in the areas of forcible entry, ladder work, fire hose, salvage and overhaul, fire streams, fire apparatus and pump operation, Ventilation, rescue and protective breathing, first aid, defensive driving, Fire prevention and inspection, and arson detection.

Many times, we as firefighters are placed in tremendously hazardous situations. We must be proficient in our actions and activities in order that we do not cause harm to be fall on our fellow firefighters. We must also be proficient in firefighting in order to prevent injury or further injury to civilians, either directly or indirectly involved in our activities, while we are sitting in a time of emergency.

The point to remember above all is that when we say, "We'll be right there," We must know what we're going to do when we get there.
